UPDATE TO SHAREHOLDERS FOR HALF YEAR ENDED 31 DECEMBER 2007

In anticipation of the announcement for the half year ended 31 December, the Board of Directors of Lasseters Corporation Limited (“the Company”) would like to issue a market update that the Company is likely to announce a pre-audited loss in the vicinity of \$1,900,000 at EBITDA Level (Earnings before Interest, Tax, Depreciation and Amortisation) for the half year results.

The results reflect the impact from the passing of the Unlawful Internet Gambling Enforcement Act, which prohibits online gaming in the United States, on Lasseters’ online casino coupled with the costs incurred in the marketing and build up of the new online Sportsbook operation, Lasseters Sports.

Full trading results for the period are scheduled to be released to the ASX on or before February 14th 2008.
